### Alcohol Consumption and Smoking Policy Agreement

The client, by signing this agreement, accepts responsibility for all clauses that follow.

Allowing alcohol consumption does not mean you have a right to consume alcohol for the purpose of drunkenness. Responsible drinking applies not only in bars, but limousines as well.

**Sober Group Chaperone:** A sober passenger (Chaperone) over the age of 25 must be assigned to each vehicle that is consuming alcohol. The chaperone must be available by phone the entire trip and must be willing to intervene if situations occur that go against the rules below.

**The Sober Group Chaperone is responsible for relaying and enforcing the rules below:**

1. No one under the age of 21 may consume alcohol. If this occurs, the Driver will immediately contact the police to have the passenger removed from the trip.
2. All passengers must consume alcohol responsibly. The Driver has the right to refuse service or transportation to any passenger who is endangering the safety of the passengers, vehicle, or equipment. This includes the alcohol consumed **before** entering the limo and after reaching the destination.
3. The group is responsible for any fees from excessive cleaning or damage.
4. The group is responsible for any physical harm that occurs due to intoxication. This includes, but is not limited to: injury, loss, death, or damages (including reasonable attorney's fees and expenses). The group will not hold **Peoria Executive Limousine Services, Inc.** responsible for any incidents occurring in part, directly, or indirectly from the consumption of alcoholic beverages.
5. The group will collect and throw all trash in the garbage once the limo has returned.
- 6. Illinois State Law dictates: NO Passengers with a Blood Alcohol Level (BAC) of .08% or greater will operate a motor vehicle.** If a cab or UBER is needed, once you arrive at your destination, please call for alternative transportation.

**Smoking: THERE IS NO SMOKING OF ANY KIND OF ANY SUBSTANCE UNDER ANY CIRCUMSTANCE IN THE LIMOUSINE** (this includes vaping). Anyone caught smoking in the limousine will be asked to cease immediately. A second warning will result in termination of the run and a \$250 cleaning and disinfecting fee charged to your credit card.

By signing this agreement, you and your chaperone understand and will be responsible to see that all the above items are adhered to.
